

2010 BI-STATE REGIONAL FUTURITY RULES & CRITERIA

Affiliating HIO's Rules Apply

The Bi-State Regional Futurity will be shown in the following divisions:

Weanling Colts		
Weanling Fillies	Two Year Old in hand/in bridle	Three Year Old Lite Shod Specialty
Yearling Colts	Two Year Old Lite Shod Specialty	Three Year Old Park Pleasure Specialty
Yearling Fillies	Two Year Old Park Pleasure Specialty	Three Year Old Trail Pleasure Specialty
Yearling In-Hand Extended Gait	Two Year Old Trail Pleasure Specialty	

All entries must be the product of Stallions and Mares who have been registered by the TWHBEA. Exhibitors/Owners must present a copy of the registration papers on the entry they are nominating for the futurity.

NOMINATION OF SIRE: To nominate a Stallion in the Bi-State Regional Futurity it is necessary:

- (1) That the stallion be registered in the TWHBEA Stud Book.
- (2) That a nomination fee of \$30.00 is to be paid to this futurity on or before October 10th of the year in which the foal is nominated.
 - The Sire Nomination Fee is a one-time fee for all of his foals born the year the Sire is nominated and is good for the duration of that foal crop's futurity career.

NOMINATION OF DAM: To nominate a Mare in the Bi-State Regional Futurity it is necessary:

- (1) That the mare be registered in the TWHBEA Stud Book.
- (2) That a nomination fee of \$20.00 be paid to this futurity on or before October 10th of the year in which the foal is to be eligible for the Weanling Division of the futurity.
 - The Dam Nomination Fee is a one-time fee and is good for the duration of the foal's futurity career.

THE WEANLING DIVISION: In order to make a foal eligible to be shown in the Weanling Division of the Bi-State Regional Futurity the following conditions must be complied with:

- (1) The Sire and Dam must be nominated in this futurity the year in which the foal is born.
- (2) The foal must be registered on or before October 10th OR proof of registration applied for by October 10th of the year in which it is born.
- (3) A \$20.00 nomination fee payable by October 10th of the year the foal is born.
 - A Foal Nomination Fee must be paid each year of the foal's futurity career.
- (4) A \$10.00 class entry fee payable by October 10th.

Weanlings will be shown in hand and will be exhibited separately by gender; i.e. fillies/colts.

THE YEARLING DIVISION: In order to make a colt, filly, or gelding eligible to show in the Yearling Division of the Bi-State Regional Futurity, the following conditions must be complied with:

- (1) The yearling must have been entered in the Weanling Division of this futurity and all conditions and requirements of that division must have been fulfilled.
- (2) A \$25.00 nomination fee must be paid to this Futurity on or before October 10th of the year following the birth of the foal.
- (3) A \$10.00 class entry fee payable by October 10th.

Entries in this division will be shown in hand and will be exhibited separately by gender; i.e. fillies/colts and geldings.

THE TWO YEAR OLD DIVISION: In order to make a colt, filly or gelding eligible to show in the two year old division, either trail pleasure, lite shod pleasure, park pleasure or two year old in hand/bridle:

- (1) The entry must have been entered in the Weanling and Yearling Division of this futurity and all conditions and requirements of those divisions must have been fulfilled.
- (2) A \$25.00 nomination fee must be paid to the futurity on or before October 10th of the year the entry becomes a two year old.
- (3) A \$10.00 class entry fee payable by October 10th.

How to show:

- (1) Trail Pleasure horses are to be shown under saddle at a flat walk and a running walk.
- (2) Lite shod pleasure horses and park pleasure horses are to be shown at the flat walk and running walk, set tails and artificial appliances (i.e. chains or action devices and pads) are prohibited. **Bands in Lite Shod are dependent on Affiliation**

PARK PLEASURE CLASSES: bands allowed.

- (3) Plantation horses exhibited in in-hand/in-bridle class are to be shown both ways of the ring and stand quietly in the line up; set tails and artificial appliances (i.e. chains or action devices and pads) are prohibited.

THE THREE YEAR OLD DIVISION: In order to make a colt, filly or gelding eligible to show in the three year old division, either trail pleasure, lite shod pleasure, or park pleasure of the futurity, the following conditions must be complied with:
 (1) The colt, filly or gelding must have been entered in the Weanling, Yearling, and Two Year Old Divisions of the futurity and all conditions and requirements of those divisions must have been fulfilled.
 (2) A \$25.00 nomination fee must be paid to the futurity on or before October 10th of the year the entry becomes a three year old.
 (3) A \$10.00 class entry fee payable by October 10th.

How to show:

- (1) Trail pleasure horses are to be shown at a flat walk and a running walk.
- (2) Lite shod pleasure horses and park pleasure horses are to be shown at a flat walk and a running walk, set tails and artificial appliances (i.e. chains or action devices and pads) are prohibited. **Bands in Lite Shod are dependent on Affiliation**

PARK PLEASURE CLASSES: Heavy shod, bands allowed.

"BUY IN" SPECIAL INFORMATION

The Bi-State Regional Futurity will not assess penalties on previously un-nominated horses. However, nomination fees for Sire, Dam, and previous as well as current fees must be paid to "buy" a previously un-nominated horse into the futurity.

Buy in as a yearling - \$105.00

(includes)

- Sire Nom. Fee \$30
- Dam Nom. Fee \$20
- Weanling Nom. Fee \$20
- Weanling Class Entry Fee \$10
- Yearling Nom. Fee \$25

Buy in as a 2 Yr. Old - \$140

(includes)

- same as yearling, plus
- Yearling Class Entry Fee \$10
- 2 Yr. Old Nom. Fee \$25

Buy in as a 3 Yr. Old - \$175

(includes)

- same as 2 Yr. Old, plus
- 2 Yr. Old Class Entry Fee \$10
- 3 Yr. Old Nom. Fee \$25

The current year's class entry fee will also be due.

PREMIUM SCHEDULE

Payouts will be made to places 1 thru 6. Ribbons will be given to places 1 thru 10.
